- Proof-of-Reserve system with Chainlink oracles and public transparency dashboard for realtime verification.



Phase 1: Current Implementation

DWIN stablecoins are currently pegged to major global currencies:

- USDDW (US Dollar)
- EURDW (Euro)
- GBPDW (British Pound)
- JPYDW (Japanese Yen)
- CNYDW (Chinese Yuan)
- MYRDW (Malaysian Ringgit)



Phase 2: ASEAN Expansion

This phase targets ASEAN expansion, introducing new currencies across Southeast Asian markets:

- PHPDW (Philippine Peso)
- IDRDW (Indonesian Rupiah)
- VNDDW (Vietnamese Dong)
- THBDW (Thai Baht)



Phase 3: Global Diversification

Phase 3 diversifies into key emerging markets, prioritizing high remittance regions:

- BRLDW (Brazilian Real)
- MXNDW (Mexican Peso)
- ZARDW (South African Rand)
- NGNDW (Nigerian Naira)

Asset-Backed Stablecoins

Commodity-Backed Token Development

USD DWIN is expanding beyond fiat-backed stablecoins to introduce asset-backed tokens, integrating physical commodities with blockchain for stability and transparency.



OILDW: Oil-Backed Token

OILDW tokens represent fractional ownership of audited physical oil reserves on the blockchain, bridging traditional oil markets.



XAUDW: Gold-Backed Token

XAUDW is pegged to physical gold reserves, verified by independent audits, offering institutional investors digital exposure to precious metals.



Future Expansion

Research is underway for additional commoditybacked tokens, including silver, renewable energy credits, and carbon offset tokens, promoting sustainable finance.

Executive Leadership


Key executive roles ensure strategic direction and operational excellence:
